



Rally Fee Cancellation Policy

A full refund will be issued for cancellation 60 days prior to rally start date for any reason. No refund will be made for circumstances less than 60 days prior to rally start date except for medical reason of member or spouse, or death in the member's immediate family. Cancellations less than 60 days in advance of rally will result in $\frac{3}{4}$ of the rally fee being credited to your account and the other $\frac{1}{4}$ being applied to current rally fees. The rally fee credit must be used for the next rally or forfeited. No cash refund.

Affirmative Covenants

We are members of the Road Hogs Motorcoach and Motorcycle Club, an Ohio non-profit corporation ("Club"), which is participating in the Rally.

We own the bike and coach which we are using during the Rally.

We have sufficient liability and property insurance to cover any incident arising during the Rally. We will pay for all damage caused by either of us, our coach, and our bike.

We are experienced coach drivers and bike riders and are cognizant of all risks which may be associated with group coach and bike expeditions.

We will follow all laws and Club rules regarding the operation of our coach and bike.

We acknowledge that we have voluntarily chosen to join other Club members in the Rally, fully understanding and accepting that the Rally and all associated activities have been organized by other members who have no special knowledge or training in the organization or operation of such gatherings.

Assumption of All Risks

As partial consideration for participating in the Rally, each of us hereby assumes ALL risks which may arise during the Rally. It is impossible to specify every possible risk, but by way of illustration, we assume all risks which arise as a result of adverse weather, inadequate accommodations, problems with directions, our own acts or those of others, mechanical problems, inadequate or unsuitable instructions, or other aspects of the Rally.

Indemnification

As partial consideration for participating in the Rally, each of us (on behalf of ourselves, our heirs, and the administrators of our estates) hereby indemnify the Club, Rally Organizers, Ride Leaders, Club Administrator, Safety Team, their families and estates, from any and all liability, claims, damages, judgments, and causes of action, including attorneys' fees and costs, which may arise from our participation in the Rally.

I HAVE READ THIS ENTIRE DOCUMENT, UNDERSTAND IT FULLY, HAVE HAD THE OPPORTUNITY TO ASK QUESTIONS AND HAVE THEREAFTER FREELY CHOSEN TO SIGN THIS DOCUMENT, UNDERSTANDING THAT IT IS FULLY ENFORCEABLE AGAINST POTENTIAL CLAIMS WE MIGHT ATTEMPT TO MAKE.
